## State-by-State Guide to Sports-Betting in the USA

In May, the United States Supreme Court finally gave the go ahead for New Jersey to offer sports betting. In one of the most significant developments in years, the decision will utterly transform the gaming market in the United States.

Now that Governor Phil Murphy has signed Assembly Bill 4111, allowing sports betting at New Jersey casinos and racetracks, attention is now turning to other states to see how sports betting will be permitted and under what conditions.

New Jersey's efforts were backed by at least twenty states and the National Governors Association. Lawmakers in a number of states are already moving forward with plans to open up the market. In June Delaware became the first state outside of Nevada to offer full sports betting. A staggering \$9.8 million was wagered in Mississippi casinos during the first month of sports betting in the state.

At the same time a number of state governments have already introduced legislation that could reverse prior state prohibitions on sports betting now that the Professional and Amateur Sports Protection Act (PASPA) has been overturned. However, estimates as to the final number of states which will ultimately allow for sports betting range from less than half to as high as forty-eight and the picture is a varied one. In addition, while a number of states seem eager to regulate the industry, in others states there is considerable opposition meaning the road to liberalisation could be a long drawn out battle lasting years.

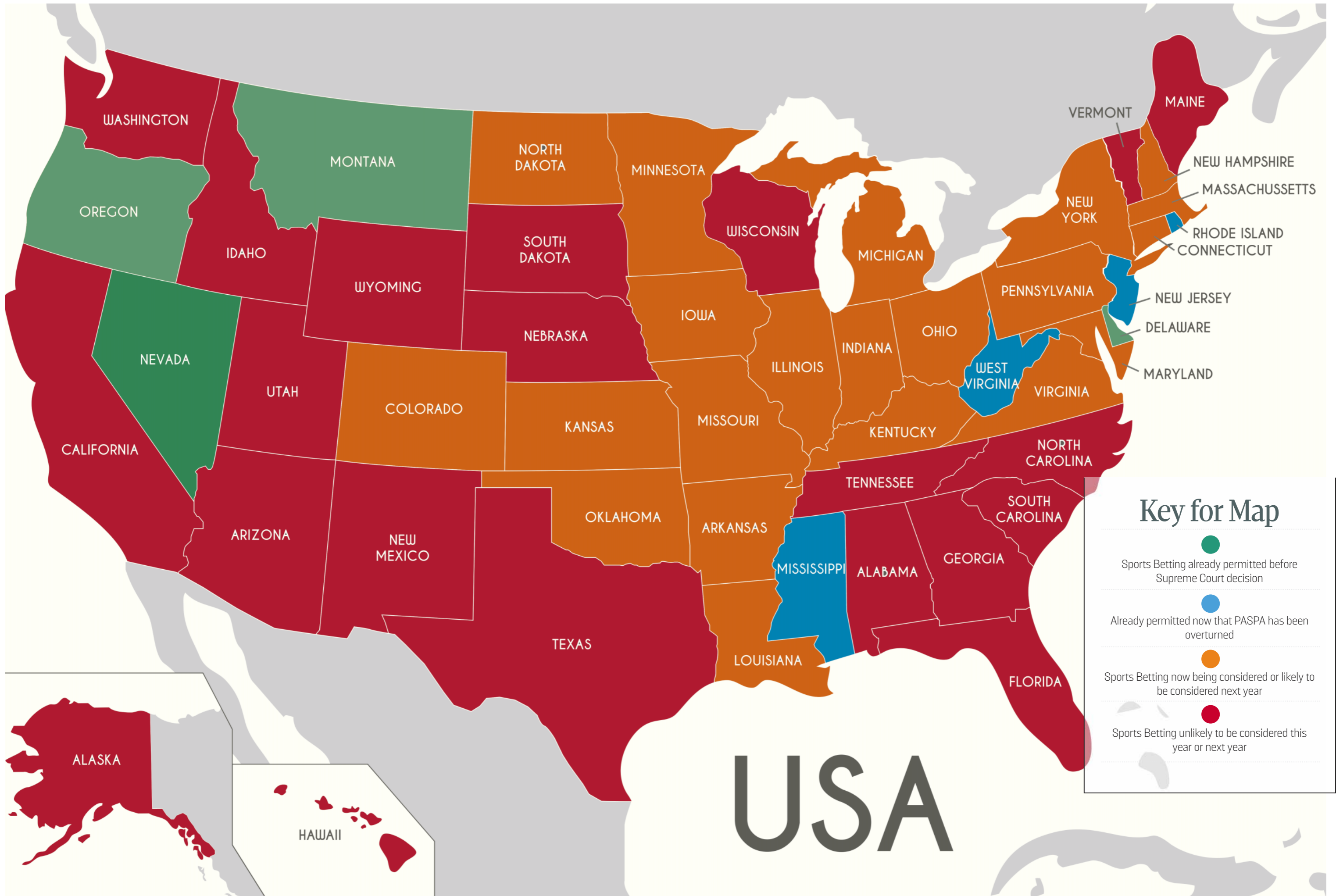
Either way states and sovereign tribal nations now have the power to create a sports betting market that will protect consumers, preserve the integrity of the games, empower law enforcement to fight illegal gambling, and generate new revenue for states, tribes, sporting bodies, broadcasters and many others.

With legislation now under consideration in several states, this state-by-state map highlights the most recent and significant changes at a glance while the state guide summarises the most recent regulatory changes and the potential likely outcomes in each state.

## Alabama

### Legislative Summary

Lawmakers have been against gambling for many years and it is unlikely that the state will permit sports-betting. Many elected officials remain opposed to any form of gambling. There are only three casinos in operation operated by the Poarch Band of Creek Indians, and no table games are permitted. Gov. Kay Ivey has not commented on whether she supports sports-betting, but popular opinion would probably go against the move. Rep. Paul Lee from the Alabama legislature, however, has said that the state legislature could look at the issue during the next legislative session in 2019, which would call for a referendum on sports-betting, though he said its chances of passing are very slim

### Legislative Summary

Although Gov. Doug Ducey voiced support for new legislation that would legalise sports gambling and tribal leaders have expressed willingness to change the terms of their licences in order to allow for sports betting, it could be five to seven years before Arizona gives the green light to sports-betting according. Gaming compacts with tribes will begin to expire after 2022. Under a possible new deal the tribes would get the exclusive right to offer sports-betting.

## Alaska

### Legislative Summary

Gambling is restricted in Alaska. Change to gambling laws in Alaska look unlikely and no bills have been introduced for the legalisation of gambling within state lines.

There are no land-based sports books or racetracks in this state. Charity gambling legislation does allow some quasi-sports gambling opportunities. For example you can guess the timing of dog-mushing (sled race) contests, with the closest guess winning a prize – or bet on salmon fishing contests...



## Arkansas

### Legislative Summary

Current state law prohibits any kind of sports gambling except for state-sanctioned races. No laws have been put forward for the 2019 legislature. However, a drive is underway to allow for sports-betting at casinos and racetracks. One new proposal could allow up to three casinos and voters may be given the opportunity to decide if the proposal makes it to the November 2018 ballot. The new act would allow for an expansion in resort type casino gaming and would legalise sports-betting. In September it was revealed that a proposal from advocacy group 'Driving Arkansas Forward' had collected enough signatures to earn a spot on the ballot in the upcoming November election. It would allow for sports-betting at four casinos.

A drive is underway to allow for sports-betting at casinos and racetracks. One new proposal could allow up to three casinos and voters may be given the opportunity to decide if the proposal makes it to the November 2018 ballot. The new act would allow for an expansion in resort type casinos

#### Legislative Summary

In California changes to gaming law could take years. A law is pending after State Assembly member Adam Gray introduced a constitutional amendment in 2017, however, before any betting law can be passed by the California legislature, an amendment to the state constitution must be made which, according to some predictions, will not take place until 2020 at the very earliest. In addition, the land-based gambling industry is mostly restricted to tribal casinos and racetracks. In California, the tribes have the exclusive right to offer casino-style games and they are not currently in favour of legalising sports-betting. However, in August the California attorney general's office had approved the title and description for a potential sports-betting amendment to the state constitution that is eligible to appear on the 2020 ballot.

### Delaware

Delaware was the first state outside of Nevada to allow for sports-betting and full-scale sports-betting launched on June 5. Sports wagering in Delaware will be administered by the Delaware Lottery. ### Colorado

#### Legislative Summary

While changes to the law are likely the timetable could depend upon whether a change to the constitution is needed to allow for sports-betting. According to an opinion put forward by Colorado's Attorney General, betting on sporting events in Colorado would not require a constitutional amendment, but would only require a change in state law. There is cross party consensus on the issue and lawmakers are expected to push for sports-betting next year. However the issue is expected to meet fierce resistance from already existing land-based operators with The Colorado Gaming Association already saying that it will block the move.

According to an opinion put forward by Colorado's Attorney General, betting on sporting events in Colorado would not require a constitutional amendment, but would only require a change in state law.



### Connecticut

#### Legislative Summary

In July 2017, Governor Malloy signed a bill into law with provisions that allow the state to move forward on sports-betting regulation contingent on changes at the federal level. The state has agreements with federally recognised tribes who operate Mohegan Sun and Foxwoods Resort Casinos, both of which currently have exclusive rights to certain forms of gambling. Malloy has been negotiating with the tribes on the question of where sports bets could be placed and how gaming revenue would be divided. The tribes argue that they have exclusive rights to operate sports-betting in the state, but local lawmakers do not agree. Malloy is leaving office in January and could let his successor deal with the matter. In August, Malloy said that a special legislative session to take up legalised sports betting appears unlikely due to opposition among Connecticut legislators to take up the issue at this point.

## Florida

### Legislative Summary

Opposition is strong amongst lawmakers and the state would have to first rework compacts with the Native American Seminole Tribe, which is against expansion. The Seminole Tribe is in turn backed by Disney Worldwide Services, which is opposed to any further expansion as well. On the Nov. 6 general election ballot, Florida voters will go to the polls to decide whether to approve state constitutional Amendment 3, the "Voter Approval of Casino Gambling Initiative." The Amendment would require a statewide referendum before any expansion takes place. It would take 60 per cent approval for it to pass. If passed it will change the Florida state constitution, giving voters the right to decide on casino gambling and casino-style games. A new poll shows that 71 per cent of likely Florida voters support Amendment 3, meaning that momentum is gathering slowly for changes to how gaming is regulated in the state. However, it is unlikely that the state will allow for sports-betting given the strong opposition from powerful interest groups in the state.

### Legislative Summary

No pending sports-betting legislation. There is no consensus on the issue and it will not be easy to change the law as the Georgia constitution currently bans all forms of gambling, with the exception of lottery tickets and non-profit bingo games. Hawaii is currently one of only two states without any form of legalised gambling.

In fact, the only kind of gambling permitted in the Aloha States is social gambling, but only if it is not committed in a hotel, motel, bar, nightclub, or any business establishment or public place.**

**IGT will be competing in the newly emerging U.S. betting market with a new, end-to-end sports betting system. Could you tell us more about this system?**

**Charles Cohen:** IGT is a B2B company in its US sports business. When a customer requires more hands-on support such as risk management, we are looking to combine forces with a partner who is able to provide that service. In Rhode Island, for example, we partnered with William Hill to provide the operational services which the Lottery required in their REP.

**How will IGT technology for sports betting specifically meet the demands of the sports betting market in the US as it continues to develop and expand?**

**Charles Cohen:** Every state is going to have its own regulation, standards and procedures. A lot of the work we completed in the past few years was directed toward creating a modern, adaptable construction that would position IGT to thrive in that complex environment. New Jersey and Mississippi were two good examples of that in action and I think you can say we passed the test. But that's not the only dimension here. There's also the Wire Act, which makes it illegal for bets to cross state lines. IGT built technology that solves many of the operational challenges posed by this.

In Idaho, the state constitution currently prohibits all types of gambling except for a state-sanctioned lottery, pari-mutuel betting, which is most typically used in horse racing, and bingo or raffle games operated by qualified charitable organisations. The Idaho State Lottery is one of the only legal forms of betting in the state. This is likely to remain the case for some time yet.

## Illinois

### Legislative Summary

A number of sports-betting bills were put forward before the Supreme Court decision and momentum has been growing for some time. Lawmakers have also been trying for several years to expand the industry in general. Sports-betting could be permitted under a Gambling Omnibus Bill, which would seek to expand other aspects of the gaming industry. The expansion bill did not cover fantasy sport-betting, internet wagering nor sports-betting. However, under the bill new casinos would be permitted along with gambling terminals at horse racing tracks. While the bill did not get past a House committee in May, lawmakers could reintroduce the bill so that it covers sports-betting as well. A joint hearing of House and Senate committees in August took more testimony on the bill. The bill seeks to widen the scope of gambling in order to bolster state finances and sports betting will be part of another hearing scheduled for October.

The expansion bill did not cover fantasy sport-betting, internet wagering nor sports-betting. However, under the bill new casinos would be permitted along with gambling terminals at horse racing tracks.

Alan Morrison in January, which allows for sports wagering at riverboats, racinos, and satellite facilities. It also allows for online sports-betting. After the Supreme Court decision Speaker of the Indiana House of Representatives Brian Bosma said that the study committee would lay the necessary groundwork for consideration next year. In August The Indiana Gaming Commission signed a deal with a Vegas-based consultancy, which will advise lawmakers on the possibilities of sports-betting as they prepare to draft legislation next year.

After the Supreme Court decision Speaker of the Indiana House of Representatives Brian Bosma said that the study committee would lay the necessary groundwork for consideration next year. In August The Indiana Gaming Commission signed a deal with a Las Vegas-based consultancy which will advise lawmakers on the possibilities of sports-betting.

The repeal of PASPA could not have come at a better time for the professional sports leagues in the United States. With viewership stagnating for some leagues and even on the downturn for others like the NFL, legalized sports betting is the shot in the arm that was needed to reignite growth in viewership for sports again.

NBA commissioner Adam Silver knew this even back in 2014, when he penned an Op-Ed in the New York Times calling for the legalization of sports betting. While other commissioners remained silent on the issue, the NBA was front and center lobbying for regulation that would allow its fans to be more engaged with the games.

The once exciting matchup of the Oklahoma City Thunder vs. the Golden State Warriors is now much less intriguing since superstar Kevin Durant left OKC and joined forces with Steph Curry and Klay Thompson in the Bay Area.

Fantasy Sports has no doubt been able to help keep football exciting because participants can draft players from over half a dozen teams, and even if a game is lopsided, there is still a reason to watch until the end if you need 5 more yards from Todd Gurley as the Rams run out the clock. Not all sports are created equal when it comes to fantasy sports, however. The NFL accounts for 90% of fantasy sports entries according to most

studies, so the other leagues have not seen a similar effect. With sports wagering, the NBA and MLB do considerably better, where their much longer season schedules are a huge benefit.

The influx of new viewers caused by their ability to wager on sports will generate demand for TV broadcast and live streaming platforms to provide access to all matchups. Social media and tech giants have gotten in on the action, with Twitter paying up for the rights to Thursday

night football last year, and this year Amazon cutting a deal with the NFL to provide live streams to their members. The leagues can now sit back as a bidding war takes place for the rights to stream their content. The platforms that are quick to snatch up the leagues' content will be able to enjoy increased engagement among their users at the expense of their competitors.

We expect to see many new platforms springing up soon, with streaming becoming the primary means for fans to consume games. It will be interesting to see how networks are able to integrate sports betting flavor into their broadcasts. Already, ESPN has begun talking about which teams will 'beat the spread' on College GameDay versus what we usually see of commentators picking who will win outright.

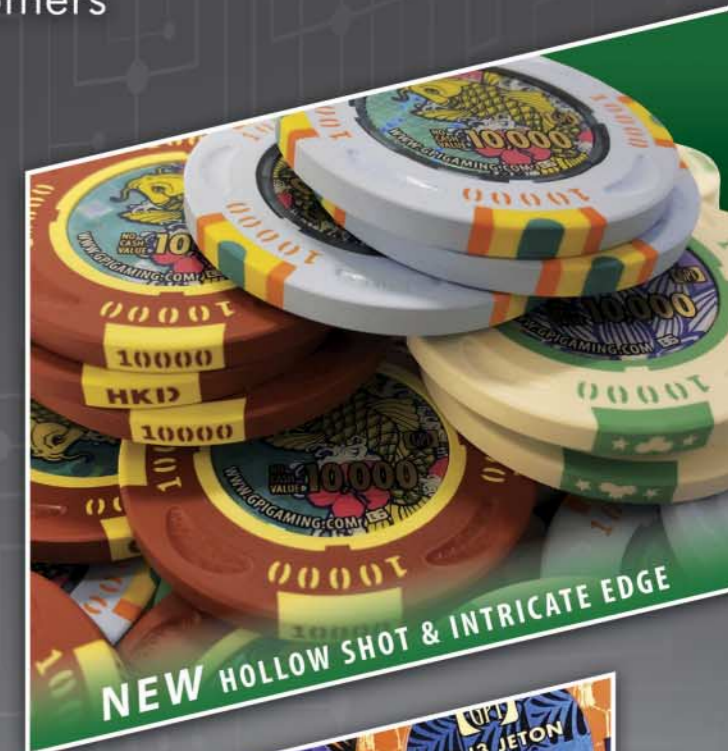

The state's neighbours Arkansas is pushing for sports-betting expansion as could Ohio, meaning the state will lose money to its neighbours, which look set to regulate the industry. However, a timetable of any pro gambling law is hard to predict. It could be up to two-and-a-half to three years before the state passes any sports-betting bill.

In January Massachusetts state senator Eileen Donoghue proposed a bill looking to permanently legalise daily fantasy sports in the state, which would also allow for sports-betting as well. The bill includes a section that creates an eight-person special commission to "conduct a comprehensive study and offer proposed legislation relative to the regulation of online sports-betting" if the Supreme Court deemed any part of PASPA unconstitutional. The commission would be charged with making recommendations within 120 days of the court's decision. The Gaming Commission has already laid out issues for lawmakers in a White Paper published in March. After the Supreme Court ruling Democratic State Senator Eric Lesser said a consensus was growing among lawmakers that the legislature needs to move quickly on the issue. In June, the House Chairman said that the "potential game plan" is for the House to research the issue now so it can act in early 2019. However, how sports-betting would be regulated is still unclear as are the government's plans when it comes to online gaming. Either way legalised sports-betting will almost certainly be approved.

The Montana Legislature has authorised limited legal gambling in Montana. Poker, keno, bingo, and video line gambling machines are legal with a maximum \$2 bet and \$800 payout. Legal live games include: raffles, bingo, keno, panguingue, poker and shake-a-day. Sports pools, fantasy sports leagues and sports tab games are also legal. These are non-banking games in which players bet against and settle with each other rather than betting against and settling with the house.

We believe that the combined global reach of Scientific Games and Caesars will be a benchmark for industry experts—we want to set the stage for unparalleled success in the U.S., and Caesars is just the partner for it. We've already begun accepting bets at Caesars properties in New Jersey and Mississippi, so we already view it as a successful and lucrative partnership. Going forward, we plan to work with Caesars as the market evolves to better respond to player needs and continue improving our product.

**Scientific Games' Digital division will power the Caesars properties. Could you tell us more about OpenBet sportsbook technology? So how does it work? What is it? And how it will work in New Jersey and Mississippi?**

**Keith O'Loughlin:** OpenBet comprises many technologies that combine to form one powerhouse product that leads the sports betting market. It includes retail electronic point-of-sale terminals, self-service betting terminals, in-venue screen solutions and accompanying digital and mobile solutions.

Essentially, OpenBet is the system that keeps the sports betting operation running, processes the transactions, and offers up the bets to consumers. However, the end user doesn't experience OpenBet as a brand. Our technology operates under our customers' brands, so in the case of Caesars, a bettor never leaves a Caesars-branded environment, whether it be mobile or in-venue, to place a bet.

**Do you think it possible that Scientific Games will operate in any other states in the United States? Are there any other agreements under discussion or on the way that you might be able to tell us about?**

**Keith O'Loughlin:** While we can't comment on ongoing discussion with potential customers, we can say that we are very optimistic about the future of sports betting in the United States. Early adopters have shown that there are various viable sports betting models, and we believe that when those first-to-market states start seeing the benefits, other states will follow suit.

As the market matures, we maintain a strong commitment to regulated jurisdictions and stand ready to support operators wherever sports betting is legal. We are uniquely positioned to provide a robust and compliant solution to any sports betting operator who wished to open up an offering in the States.

A few states already have legislation in the works, so we think it's just a matter of time before we see widespread legalisation.

Scientific Games has the experience of working across various legislations and regulators across the States and this will stand us well in launching our sports betting offering across new states that open up.

**Are there any unique challenges which the U.S. market might offer? If so, how will Scientific Games be able to meet these challenges?**

**Keith O'Loughlin:** We have loads of experience in other markets like the U.K. and Australia, so we feel uniquely equipped to address the

specific challenges posed by the U.S. market. One obvious obstacle is the different tastes of the average U.S. consumer. In the U.K., football (soccer) reigns supreme. In the States, you have football, basketball, baseball, and hockey dominating the market. We want to be sure that Stateside bettors have an offering that matches their interests.

The U.S. customers also expect an unmatched experience from start to finish. If the solution isn't intuitive, we run the risk of losing them. So we're working diligently to ensure our mobile and in-venue solutions are seamless and simple. A great parallel can be found in the streaming world. A pop culture enthusiast can enjoy his favorite shows on Netflix literally anywhere—on the bus to work, at home, etc. That omni-channel experience is crucial to the U.S. consumer, and we aim to mirror that approach with sportsbook. Sports betting should be viewed as an entertainment channel, and thus, it should reflect the widespread availability of more seasoned channels. It's a big project, but it's worthwhile to keep the players happy!

**Very generally speaking, how do you see the market going forward?**

**Keith O'Loughlin:** It's a very unique market, and while its future isn't easy to predict, we do expect a few key shifts to come in the near future. Right now, speed-to-market is top-of-mind for operators, and the industry is flooded with providers that promise all sorts of bells and whistles in no time at all. As the market matures, we think the mindset will shift more toward reliability and performance. As the market matures, customers will want a lot of flexibility to be able to evolve and differentiate themselves to retain and maintain their customers. Speed will always be prevalent, but to survive in the long term, operators must have a solid, proven platform.

We also expect that, as the average bettor learns more and more, we'll see growth alongside that learning. It's a new ball game, and players will want to learn the ropes before diving headfirst into the world of sports betting. But when the entertainment value becomes apparent, we think new sports betting experts will emerge every day.

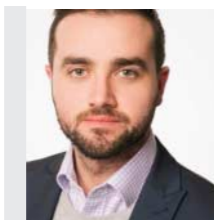

**Kambi Group has signed a multi-year deal to provide its Sportsbook and technology to Rush Street Interactive. Could you tell us more about the deal? How will it help further Kambi's entrance and expansion into the US market?**

**Max Meltzer:** The Rush Street deal is a very significant one for Kambi for a number of reasons. Firstly, they have a very good management team which understands the business and what it takes to succeed – they are aligned with Kambi and our strategy, so it makes for a powerful partnership. Secondly, having a retail presence is important when looking to gain market access – those with the bricks and mortar businesses holding the key to operators and suppliers gaining a license. Third, Rush Street is familiar with the online market having launched its Sugar House brand online in New Jersey with great success – they know how customer acquisition, retention, onboarding, marketing, etc. works – which is a good head start on some of the others entering this space.

Finally, Rush Street also has a very modern technology platform which now has the Kambi Sportbook integrated very deeply into it. Not only does this give Rush Street great autonomy over the sportsbook, enabling to mould it to its individual needs, but it has created a full sportsbook and gaming turnkey solution which could be leveraged by operators in other states. We launched our Sportsbook with Rush Street through its Sugar House brand in New Jersey at the end of August and the results so far have been very encouraging. We look forward to doing similar in other states.

**Regulation is likely to vary greatly from state to state so how will Kambi's business and technology fit into state-by-state regulation of**

**sports betting. Will it be able to suit different regulations in different states and if so how?**

**Max Meltzer:** Varying regulations across America is simply a reflection of what we see, and have dealt with effectively, in Europe and further afield. Kambi is active in regulated markets across the globe, covering six continents, so we are confident our technology can handle whatever state regulations throw at us. As an example, earlier this year we launched three different customers into three different regulated markets within the space of a week. This was possible due to our clean and flexible technology, as well as our corporate probity, which enables us to gain licences quickly and without issue to enter new markets. Coming back to the US, Kambi's ability to handle differing regulations is one of the key reasons why we were first to launch in the New Jersey online market, helping our customer take that first historic bet, and then a million more before others had even entered the market.

**How will Kambi's sports betting services appeal to American sports enthusiasts in particular? So how will its high-quality Sportsbook be different from its offering in other countries than the U.S.?**

**Max Meltzer:** To start, Kambi has a deep passion for US sports, which I believe feeds in to the quality of service and the markets we offer. Our meeting rooms are named after US sports stadia, our exec team is essentially full of US sports fans, and our traders and product developers bet on the games themselves so understand the sports and the markets players would want to bet on. Having this passion and experience means we already had a leading US sports wagering offer long before PASPA was repealed for our customers across the world but obviously, since that decision, we have made the service even more superior to exceed the demands of the US-based bettor.

These improvements included expanding the scope of our offer, building out our in-game product so players can, for instance, bet on result of next batter, the outcome of next drive, or the points of next throw, localising the sportsbook for the US-player, etc. We've also begun to innovate in the US. The fact there hadn't previously been legal single-game sports betting outside of Nevada means there has been a lack of innovation and modernization of the betting product as a whole. One example is teaser parlays, where operators have historically priced using an odds table as they never used to price up more than one line. As Kambi prices a wider variety of lines on the same game, we didn't see the point in using an odds table when we can just as easily give bettors the right and fair price of their teased parlay – which just happens to give greater value too. Hence Teaser+ being born, which is already proving an effective point of differentiation for our partners. On the whole, our Sportsbook has been well received in new Jersey with DraftKings, Rush Street/Sugar House and 888 all performing to or beyond expectations.

In 2011, New Jersey residents voted by a 2 to 1 ratio to legalise sports-betting. In the same year, arguing that state regulated sports-betting would raise tax revenue, create jobs, attract additional revenue from tourism, reduce illegal gambling and help the local gaming industry, New Jersey amended its constitution to allow for sports-betting. In January 2012 governor Chris Christie signed the measure into law allowing for sports-betting at racetracks and casinos in the state. The state of New Jersey had been battling it out in the courts against the major professional sports leagues that sued then-Governor Chris Christie in 2014 to stop him from allowing legal sports-betting at Atlantic City casinos and the state's racetracks. In May, the Supreme Court struck down the federal law that had barred single-game gambling in most of the country, saying it unconstitutionally forced states to maintain their prohibitions.

**Tell us about the Inspired virtual games, which were brought to the New Jersey market before the Supreme Court decision?**

**Brooks Pierce:** In late 2017, Inspired's Virtual Sports went live online in New Jersey, making it the first and only virtual sports provider in the State. The Division of Gaming Enforcement at New Jersey was able to certify our content using existing RNG content regulations and we were thrilled to place Virtual Sports in familiar betting markets in the fast-growing New Jersey market ahead of broader sports regulation. Inspired is now live with six operators, with further launches expected.

**Will Inspired operate in other states in the US? Are there any agreements under discussion you can tell us about?**

**Brooks Pierce:** Inspired recently launched a new range of virtual sports games designed specifically for the US lottery market, which are available through the Pennsylvania State Lottery and are available in more than 9,000 retail locations. The simple game play and win-picking features are similar to traditional lottery products, but introduce a new style of lottery with more immediate impact. Pennsylvania lottery players no longer have to wait for a nightly drawing, as these new virtual sports games are drawn every five minutes.

With our virtual sports content already in Nevada and New Jersey, we have many other US

lotteries and casinos speaking with us about launching similar products across their retail, casino, sportsbooks and interactive platforms. US providers see our products as an opportunity to expand their player base, as a precursor to sports betting, and as a way to add fresh, dynamic content to their gaming portfolio with a proven record of driving incremental revenues for customers globally.

Also with the recent Supreme Court ruling favoring sports betting, we've seen a surge in interest in the US for our virtual sports content. Our virtual sports content is seen as complementary and seamless to real world sports betting and has proven to drive incremental revenues for customers globally and attract new players, as the digital format mimics the type of entertainment that millennials already consume. Empirically, operators who have added virtual sports to an existing sportsbook have experienced a 25 percent increase in revenue.

Circumventing harsh gambling prohibitions, New Hampshire authorises games of chance to be played on behalf of charitable organisations. Nearly 400 charities have gotten in on the games, linking up with clubs, poker rooms, and former racetracks to create small-scale casino venues.**

**Is Inspired looking at developing any new virtual games specifically for the US market?**

**Brooks Pierce:** Inspired invested heavily in research and development and took eighteen months to create the first products designed specifically for the US lottery player: Xpress Football and Xpress Car Racing, as branded by the Pennsylvania Lottery. We used the world's most advanced motion capture facilities to produce ultra-realistic animation that would generate a true depiction of a football game that we knew lottery players would embrace. The player models were developed in ultra-high resolution including facial rigs and muscle systems, allowing for the use of super close up cameras (for the first time), which ensure that we can go right in the middle of the action.

We brought in a former Super Bowl champion player in order to create the most realistic football product possible. He was highly involved in the making of the game, providing direction during the motion capture process and reviewing the game throughout development to help create a true-to-life final product that accurately reflects the way modern football is played.

Bills in both houses are almost identical and would allow for betting on sports at the state's already existing gaming facilities. Mobile sports-betting would also be permitted. The New York State Gaming Commission is expected to issue regulations for brick-and-mortar sports-betting in September, and then there will be a 60-day vetting of the rules.

Unlike many States, which target the organisers of illegal gambling games, Oklahoma also has specific statutes criminalising players. This State makes the bet the subject of criminal proceedings as well as outlawing gambling devices (broadly defined) and profiting from the games via rake or fees. While the bet legislation focuses on games of chance, poker is covered under a separate list of illegal gambling games. Players can currently bet on horse races (pari-mutuel betting) either at racetracks or remotely. Slots machines and racetracks have been combined in Oklahoma into popular racinos.

The relationship between the USA and European has always been a close one, even before NATO was formed in 1949. ### Legislative Summary

Pennsylvania is likely to be on the forefront of any possible expansion for sports-betting under current rules. In October 2017, state governor Tom Wolf signed a law which would allow casinos in the state to allow for mobile and online games including online poker, table games and slots as well as sports-betting in casinos on both professional and college sports in casinos. The law calls for a \$10 million application fee and a 34 per cent tax on gross sports wagering revenue. In August The Pennsylvania Gaming Control Board approved a set of regulations. Officials believe they are now ready to accept applications from casino operators. While operators have been critical of the 34 percent tax, many of the 13 potential licensees are likely to get on board.

In October 2017, state governor Tom Wolf signed a law which would allow casinos in the state to allow for mobile and online games including online poker, table games and slots as well as sports-betting in casinos on both professional and college sports in casinos.

There is a tried and tested formula in Europe where by mid to large sized operator's partner with a vendor for their tech or perhaps the largest build the tech themselves, but the operational side of the business is always kept

in-house and is seen as one of biggest ways how to differentiate from competitors. In the past some of have tried outsourcing operations, normally in times of crises, and although these started well and provided a much need to kick to the share price at first over time most ended with fairly spectacular and expensive separations.

For the mature European competitive markets the player experience is absolutely key, state of the art player account management software is critical and the push for a true omni-channel strategy continues for those with a land-based and online presence. In this very early stage of the US market no doubt many of these elements are being overlooked due to the rush just to get a deal done and be online as fast as possible.

This would require the approval of two-thirds of the members of both houses, followed by a referendum which would probably not garner much support.

Utah's gambling laws prohibit citizens from betting anything of value on the outcome of a contest, game, scheme, or gaming device.

There are restrictions on most forms of gambling, even those which are legal, and concessions appear hard to obtain through the legislature. There are limited options for betting on horse racing through charities and lotteries.
